16 February 2009 - A Global Report on Trafficking in Persons launched today by the United Nations Office on Drugs and Crime (UNODC) provides new information on a crime that

shames us all. Worldwide, almost 20 per cent of all trafficking victims are children. Based on data gathered from 155 countries, it offers the first global assessment of the scope of human trafficking and what is being done to fight it. It includes: an overview of trafficking patterns; legal steps taken in response; and country-specific information on reported cases of trafficking in persons, victims, and prosecutions.

Countries and territories covered in this report include 10 MENA countries (Algeria, Bahrain, Egypt, Iraq, Israel/oPt, Morocco, Oman, Qatar, United Arab Emirates, Sudan). According to the report, the majority of countries in the MENA region have recorded no prosecutions for the specific offence of trafficking persons.

Joint UN, European initiative seeks to protect children from online dangers

10 February 2009 – The United Nations telecom agency and the European Commission have teamed up to protect children, among the most active – and most vulnerable – users of the Internet from online dangers, including cyber-bullying and paedophilia. “Child online safety must be on the global agenda,” Hamadoun Touré, Secretary-General of the UN International Telecommunication Union (ITU), said in a press release. The Geneva-based union has joined forces with the EC to mark Safer Internet Day, which includes more than 500 events in 50 countries worldwide, including the MENA region, to promote child online protection

Petition for a complaints mechanism under the Convention on the Rights of the Child

11 February 2009 - 450 organisations from around the world have signed a petition to establish a communications (complaints) procedure under the UN Committee on the Rights of the Child. In order to establish a new Optional Protocol for the CRC, the Human Rights Council (HRC) must first issue a resolution to create an open-ended Working Group to draft the procedure.

In commemoration of the CRC’s 20th anniversary this year, the HRC will be devoting a full day to the topic of children’s rights at its session in March.

UN Committee on the Rights of the Child (CRC) adopts General Comment no 11 regarding Indigenous Children and their Rights under the Convention

On 30 January 2009, the CRC adopted a General Comment on indigenous children and their rights under the Convention. The eleventh comment of the Committee is looking at the issues associated with these children who “continue to experience serious discrimination in a range of areas”, including in their access to health care and education. Low incidences of birth registration for such children and particularly high incidences of

mortality and vulnerability in armed conflict are among issues addressed in the general comment.

The combination of economic divisions and rising hardships for poor populations, plus high levels of risk for violent conflict, creates a high-risk situation for humanitarian concerns in much of the region. Conflicts in the region will likely continue to frame UNICEF's work in the coming years, as the brunt of the suffering continues to fall on civilians and most vulnerable groups, children and women primary amongst them.

Israel/oPt –Key steps to building a future for the children of Gaza

1 February 2009– As in all conflicts, children and youth are among the most vulnerable. In Gaza, 56 percent of the population are children. This translates into some 850.000 children in urgent need of a future perspective. Although they are used to violence and a dire humanitarian situation, the recent conflict has brought new horrors to their lives. Some have lost family members and homes and many suffer from traumatic experiences.

In an Op Ed by Karen Abu Aayd the Commissioner General of the United Nations Relief and Works Agency (UNRA) and Sweden's Minister for Development Co-operation, Gunilla Carlsson, they define 10 key steps to building a future for the children of Gaza, and which includes: meeting humanitarian needs, removing unexploded ordnance, the need to sustain development plans, etc.

11 February 2009– The United Nations agency tasked with assisting Palestinian refugees has distributed notebooks to 11 schools in Gaza over the past week, but has halted further distribution since it has not been able to import any additional notebooks. The UN Relief and Works Agency for Palestine Refugees in the Near East added that it has still not received permission to import the necessary paper to print the remainder of its textbooks, leaving 60 per cent of children without textbooks.

11 February 2009 - This situation analysis provides an overview of the extent to which Palestinian children living in oPt were able to enjoy their rights to protection in 2008, from a structural and practical perspective. The study focuses on the level of protection available to three particular target groups of children living in the oPt, in terms of laws, policies, mechanisms and practices. The target groups in question are children vulnerable to violence, neglect, abuse and exploitation in their homes and communities; children in conflict with the law under Palestinian Authority (PA) jurisdiction and children detained by Israel under its military order system.

Israel/oPt – New report highlights child abuse risks

Tel Aviv, 12 February 2009– Israel's National Council for the Child (NCC) published a report on 8 February in which it said 309,141 children had been described by social services as being at risk of abuse.

In most cases the main risk factors were to be found in the family environment. At-risk children faced threats, hunger, beatings, and lack of education and medical care. Some were taken out of their homes and placed in foster care or boarding schools but most were unable to get the help they needed and remained in abusive family settings, the report said.

Israel/oPt – Gaza children “afraid to return to school”

Gaza City, 23 February 2009– School-children in the Gaza Strip face psychological trauma and lack facilities after schools were badly damaged or destroyed during Israel's three-week assault on the enclave that began in December.

Primary and secondary schools in Gaza run by the government and the UN Agency for Palestinian Refugees (UNRWA) report a shortage of drinking water and textbooks for students, according to the UN Office for the Coordination of Humanitarian Affairs (OCHA).

Restrictions on the amount and type of materials being allowed into Gaza by Israeli authorities are hindering the education system.
