Brazil - Brazil's Zika Threat Remains

12 May 2017 - Brazil's public health emergency related to the Zika virus is over, the country's health ministry said yesterday. But we should not declare victory over the mosquito-borne virus. The announcement came 18 months after the government first declared Zika a national emergency, as increasing numbers of infants were born with microcephaly – a condition when the head and brain are underdeveloped – and other complications, together now known as Zika syndrome. This year the number of Zika cases, and the number of infants born with disabilities linked to the virus, have dropped dramatically.

Colombia - The Promises of Peace in Colombia

18 May 2017 - At the start of each school year, Colombian schoolchildren are still given specially prepared instruction manuals in the form of comic books to teach them how to avoid stepping on land mines. Despite these efforts, during 52 years of war, more than 1,000 Colombian children, usually from the poorest of our farming families working their fields, were killed or maimed by land mines. (...) In more than 203 Colombian municipalities, the dangerous work of locating, disabling and removing Colombia's land mines is being carried out by NGOs, specially trained units of the Colombian armed forces and the Revolutionary Armed Forces of Colombia, or FARC. The goal is to make Colombia land-mine free by 2021.

They told a conference hosted by the Washington-based Organization of American States (OAS) that victims of trafficking often face severe trauma and low self-esteem, and need long-term psychological care, job skills training, and access to healthcare and education to recover. But they said there were few government-run shelters exclusively for trafficking survivors in the region, and almost none for men and boys.

11 May 2017 - A new guide published today aims to help religious communities worldwide harness their strengths to prevent, respond to and end online child sexual exploitation. Published by ECPAT International and Religions for Peace in partnership with UNICEF, Protecting Children from Online Sexual Exploitation recognises that religious leaders and communities can provide the moral compass that is needed to end this crime.

Information and communications technologies and the Internet are exposing children to new and evolving forms of sexual exploitation, as seen in a staggering expansion of child sexual abuse materials online. Practices such as 'sexting' (the self-production and sharing of sexual messages or images) also place children at risk of sexual abuse and exploitation.

Perú - 12 mil personas del Centro Poblado Villa Vicus en Chulucanas ya cuentan con agua en sus hogares

Venezuela - Children face hunger crisis in Venezuela as malnutrition soars

16 May 2017 - Child malnutrition in parts of Venezuela is now at the level of a humanitarian crisis, warns a new report from the local Caritas agency. With the economy in freefall, shortages of food and medicine and soaring food prices, nearly half of children under five in areas monitored by Caritas are suffering from some degree of malnutrition or at imminent risk.

Caritas has been surveying child malnutrition across four states including the capital Caracas. The latest figures show that 11.4 percent of children under five are suffering either from moderate or severe acute malnutrition. The World Health Organisation's crisis threshold for child malnutrition is 10 percent.

United States - US Turning Away Asylum Seekers at Mexican Border

3 May 2017 - Two weeks ago in California, I met a 16-year-old Salvadoran boy – I'll call him Gabriel – who fled his home after gang members threatened to kill him. After traveling through Mexico, he and another boy made their way to the US border in September and tried to tell officials about the risks they faced at home.

By law, if someone arrives at the border asking for asylum or expressing fear of returning to their own country, US Customs and Border Protection (CBP) agents are required to refer the person to a specialist asylum officer, who then assesses eligibility for protection.

That's not what happened in Gabriel's case. "They just told us to wait outside," he said. The two boys sat on the Mexican side of the border for most of the day. By chance, a lawyer taking a client to the border crossing spotted and helped them.
