Thousands of families have exhausted their food reserves and are cutting down on daily meals. Up to 1.6 million children are at risk of life-threatening malnutrition...

South Sudan – “For third time this year, hundreds of children released by armed groups in South Sudan - UNICEF”

18 May 2018 - On 17 May 2018 in Pibor, South Sudan, 210 children were formally released from armed groups. During the release ceremony, the children were formally disarmed and provided with civilian clothes. Medical screenings will be carried out, and they will receive counselling and psychosocial support as part of the reintegration programme, which is implemented by UNICEF and partners. The children released today included three girls and largely came from the opposition group the SPLA-IO, with eight having been associated with the National Salvation Front (NSF). More than 800 children have been released since start of 2018. An estimated 19,000 children continue to serve in the ranks of armed forces and groups in South Sudan.
