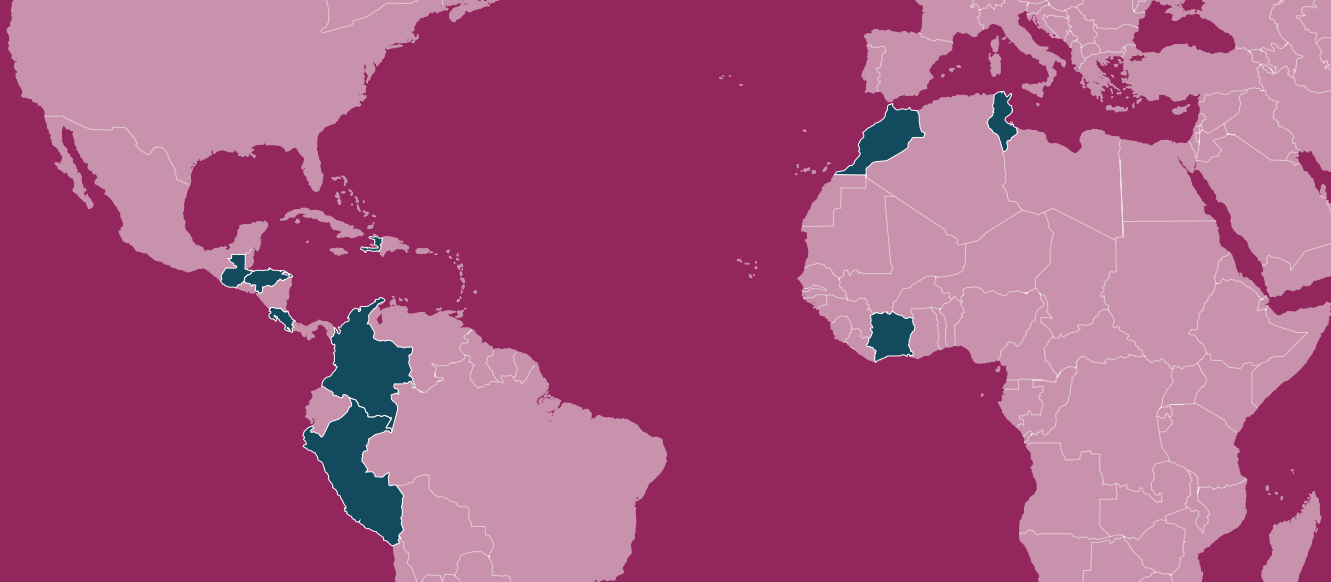

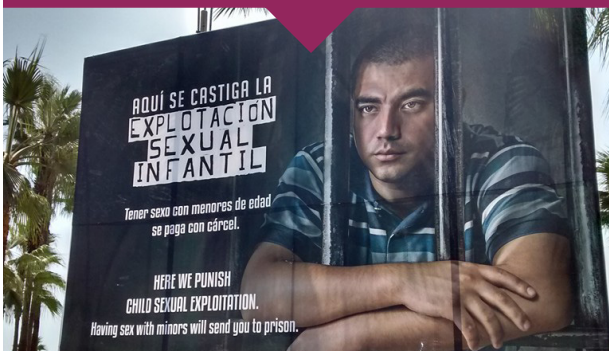

OUR RESULTS SO FAR



SOME ACCOMPLISHMENTS OF OUR VOLUNTEERS



The project **“Protection of children, women and other vulnerable communities”** (PRODEF) benefits from specific Canadian expertise and focuses on improving the protection of rights of children, women, and marginalized communities as well as on strengthening democracy and the rule of law through access to justice.

It is implemented by **Lawyers Without Borders Canada** (LWBC) in consortium with the **International Bureau for Children’s Rights** (IBCR) in conjunction with **Le Barreau du Québec** (Quebec Bar) as part of the **Volunteer Cooperation Program** funded by **Global Affairs Canada**.

Since 2015, about **20 volunteers** carry out more than **30 cooperation missions**.

- Over **15 000** women and girls have benefited from greater protection of their rights
- Over **1000** women and girls have been made aware of their rights, and prepared to go through the various stages of the judicial process
- Over **1400** victims of human rights violations—including **430** women and girls—benefited from enhanced legal representation services
- Over **130** cases handled by international authorities for serious human rights violations (forced disappearances, human trafficking, genocide, and sexual abuse)
- Over **10** legislative proposals developed in favor of the rights of children, adolescents, and women
- Training of approximately **300** female staff members within our partner organizations
- Victims have benefited from representation, providing them access to justice before international legal authorities after over 20 years since the crimes took place

- A victim of sexual violence in Colombia accepted to testify, despite her fear, because a representative from LWBC was present in the courtroom. Thanks to her testimony, the case went to appeal and the penalty was increased
- The legal support provided by a volunteer **contributed to the acquittal of human rights defenders** accused on illegitimate grounds in Guatemala
- A volunteer participated to the **elaboration of a draft law enhancing children’s protection in Costa Rica**. Her contribution led to the increase of the age of sexual consent, to the prohibition of early marriage, and to reforms of the Criminal Code
- A volunteer contributed to the **transfer of knowledge and skills in organizational management in Ivory Coast**. The developed tools allowed the partner organization to put in place new internal policies for the implementation of activities related to the protection of children’s, women’s and vulnerable communities’ rights
