#### **Colombia – Agua, Saneamiento, Higiene y Educación: prioridades del Plan de Respuesta humanitaria de UNICEF a los niños y niñas de Mocoa (Colombia)**

3 de Abril 2017 – Protección, Agua, Higiene y Saneamiento, así como Educación en Emergencias son las prioridades de la ayuda humanitaria urgente que prepara UNICEF para los niños, niñas, adolescentes y familias afectadas por el desastre de origen natural producido en la noche del 31 de marzo y madrugada del 1 de abril en Mocoa, capital de Putumayo (Colombia). Según las últimas cifras oficiales (3 de abril), todavía provisionales, la avalancha de agua ha provocado hasta el momento 254 personas muertas de las cuales se han identificado 129 personas, 262 heridas, 441 personas desaparecidas, más de 300 familias afectadas, 4 instituciones educativas afectadas y 25 casas destruidas. Se ha declarado la calamidad pública.

## **Colombia – FARC surrenders more than twice the number of child soldiers it said it had**

April 3<sup>rd</sup> 2017 – Colombia's largest, but demobilizing rebel group FARC has so far surrendered 57 child soldiers, more than double the "no more than 25" it said to have in its ranks ahead of the peace process. In a press release, the Red Cross said it had received another 16 children on Sunday at multiple camps where the FARC members are in the process of demobilization, disarmament and reintegration (DDR).

## **Columbia – Cada 36 horas, una niña se vuelve mamá en Bogotá**

23 de Abril 2017 – En Bogotá, 233 niñas tuvieron hijos entre 2016 y 2017. La mayoría de los padres tenían entre 15 y 19 años. El resto fueron mayores de 20 años. Ciudad Bolívar, Kennedy y Bosa son algunas de las localidades donde se reportaron más casos. [...] En seis años, 2.892 mujeres de Bogotá tuvieron su primer hijo antes de cumplir 14 años. El 2010 fue el año con el panorama más crítico, cuando se reportaron 515 casos. Sin embargo, al revisar las cifras del último lustro, se nota el trabajo de la Administración, pues gracias al trabajo de sus autoridades locales se ha logrado una reducción del 58 % en el índice de embarazo de niñas en toda la ciudad.

## **Guatemala – With bicycles, impoverished indigenous girls in Guatemala get a taste of freedom**

April 25<sup>th</sup> 2017 – Like many girls in Pecajbá, in Guatemala, Gladys Azucena Cho Cuc was forced to drop out when she reached secondary school. The high school was simply too far from home. In rural communities around here, girls travel an average distance of about 8 km to get to class. Their commute often takes them over corn fields and rivers, and some girls spend part of their journey in the dark.

## **Haïti, République Dominicaine – Haïti/République Dominicaine : 43 migrants haïtiens rapatriés à la frontière de Carisal/Elias Piña Spécial**

6 Avril 2017 – Les autorités de la migration dominicaine ont procédé au rapatriement de 43 migrant-e-s haïtiens, le 4 avril 2017. Vingt et un (21) d'entre eux ont été accueillis par le GARR dont vingt (20) hommes et un (1) mineur. ## **United States – Supreme Court Denial Must Not Result in Deportation of Asylum-Seeking Families**
