### 3. Subregional and Country Updates

#### **Central African Republic – Over 19,000 Displaced Following Outbreak of Violence in Central African Republic**

May 30<sup>th</sup> 2017 – The UN Migration Agency (IOM) has tracked more than 19,000 displaced people in the Central African Republic's (CAR) sub-Prefecture of Bangassou (Mbomou Prefecture), which is situated at the border with the Democratic Republic of the Congo (DRC). More than 13,000 of those displaced are children.

#### **Democratic Republic of the Congo, Angola – UNICEF reaches children fleeing to Angola from violence in the Democratic Republic of Congo**

May 30<sup>th</sup> 2017 – More than 9,000 children who have arrived at two temporary reception centres in Dundo, northern Angola, from the Democratic Republic of Congo need urgent support, UNICEF said today. To date, more than 25,000 people have arrived in Angola, having fled violence in the Kasai province of the Democratic Republic of the Congo.

#### **Iraq – Almost 10,000 Yazidis ‘killed or kidnapped in Isis genocide but true scale of horror may never be known’**

May 9<sup>th</sup> 2017 – The true scale of the genocide inflicted on Yazidis by Isis during its brutal sweep through Iraq may never be known as thousands remain in captivity, researchers have warned. A new study published in weekly journal PLOS Medicine concluded that an estimated 9,900 members of the ethnic and religious minority were killed or captured in a matter of days in August 2014.

## **Nigeria – Nigeria: First Report on Children and Armed Conflict Details Violations Suffered by Children as a Result of Boko Haram’s Insurgency and Ensuing Conflict**

May 4<sup>th</sup> 2017 – Boys and girls in north-east Nigeria continue to be brutalized as a result of Boko Haram’s insurgency in the region and the ensuing conflict. This is the conclusion of the first “Report of the Secretary-General on children and armed conflict in Nigeria” (S/2017/304), which documents the impact on children of the severe deterioration of the security and humanitarian situation in the country between January 2013 and December 2016.

## République centrafricaine – RCA : Les troupes ougandaises se sont rendues coupables d'exploitation sexuelle et de sévices

15 mai 2017 – Des militaires ougandais déployés en République centrafricaine ont sexuellement exploité ou abusé d'au moins 16 femmes et filles depuis 2015, notamment en commettant au moins un viol, et ont intimidé certaines de leurs victimes pour qu'elles gardent le silence, a déclaré Human Rights Watch aujourd'hui. Des troupes ougandaises sont déployées dans le pays depuis 2009 dans le cadre de la Force d'intervention régionale de l'Union africaine chargée d'éliminer le groupe rebelle ougandais Armée de résistance du Seigneur (Lord's Resistance Army, LRA), mais l'Ouganda a récemment annoncé qu'il allait retirer ses troupes.

## South Sudan – Civil war and lack of food wreck children's education in South Sudan

And 76% of schoolgirls in South Sudan are currently not in school - also the highest rate globally, according to the United Nations children's agency UNICEF.
