## France – Le Parlement adopte définitivement la « loi anti-fessée »

2 juillet - La proposition de loi, votée au Sénat, signe la fin du droit de correction, hérité du XIX<sup>e</sup> siècle et qui est encore invoqué dans la jurisprudence. Les sénateurs ont voté, mardi 2 juillet, la proposition de loi de la députée (MoDem) du Val-de-Marne Maud Petit interdisant les « violences éducatives ordinaires ». Soit l'éradication de toute pratique en la matière « basée sur la peur, la douleur et la sidération de l'enfant », selon le médecin généraliste Gilles Lazimi, à la pointe du combat contre ces violences ordinaires.

## Global – Post-COVID : près de 10 millions d'enfants risquent de ne jamais retourner à l'école

12 juillet - Jusqu'à près de 10 millions d'enfants dans le monde pourraient ne jamais retourner à l'école après le confinement en raison des conséquences économiques de la pandémie de nouveau coronavirus, affirme lundi l'ONG britannique Save the Children. ## European Union – Solidarity on Migrant Children in Greece Could Change Lives

7<sup>th</sup> July – On April 15, Luxembourg became the first European country to welcome asylum-seeking children, 12 girls and boys, from the Greek islands. And on April 16, 47 children arrived in Germany. These children were the first to be covered by an EU plan to move unaccompanied asylum-seeking children from Greece's overcrowded and dangerous camps, to safety in other European countries. If the plan works, at least 1,600 children in need of protection can be offered a new life.

16<sup>th</sup> July – Commission President Ursula Von Der Leyen has entrusted Vice President for Democracy and Demography to launch a comprehensive Child Rights Strategy. ## **European Union – Delivering on a Security Union: initiatives to fight child sexual abuse, drugs and illegal firearms**

24<sup>th</sup> July – Today the Commission is presenting 3 immediate initiatives to implement the Security Union Strategy: an EU strategy for a more effective fight against child abuse; a new EU Agenda and Action Plan on Drugs and an EU Action Plan on firearms trafficking. These threats all require resolute EU-level action as they are cross-border in nature and active both online and offline. They have also been worsened by the coronavirus pandemic, particularly child sexual abuse, demonstrably exacerbated by physical isolation and increased online activity.

## Pakistan – Pakistan Invests \$400 Million to Manage the Locust Outbreak and Respond to School Disruptions Due to COVID-19

31<sup>st</sup> July – The World Bank's Executive Directors approved two projects for \$400 million in concessional financing from the International Development Association to support Pakistan's interventions to reduce food insecurity from the outbreak of locusts and measures to restore education for schools closed due to COVID-19. This financing includes \$200 million for the Locust Emergency and Food Security Project and \$200 million for the Actions to Strengthen Performance for Inclusive and Responsive Education Program.

## Thailand – To catch an online predator

31<sup>st</sup> July – An increase in young children falling prey to paedophiles on the internet amid pandemic fuels concern for an overburdened task force. Over the past two months, the TICAC has rescued over 100 children from online cybersex predators, a considerable spike when compared to the total of 53 underage victims that the TICAC rescued from online sexual abuse in the whole of 2018, which at that time was the highest annual figure since the organisation was created in 2016.
