Canada - Ottawa pressé de venir en aide aux enfants prisonniers dans des camps en Syrie

14 septembre - Le gouvernement de Justin Trudeau est à nouveau appelé à intervenir dans le dossier des enfants de ressortissants canadiens qui ont décidé d'aller grossir les rangs du groupe armé État islamique (EI) en Syrie, et qui se retrouvent aujourd'hui coincés dans des camps de réfugiés, sans aide consulaire du Canada. La violence, l'insalubrité et la famine règnent dans ces camps, où se trouvent 26 enfants canadiens, selon l'ONG Human Rights Watch (HRW).

3 septembre - Un rapport publié mercredi par l'UNICEF affirme qu'avant même l'éclatement de la pandémie du nouveau coronavirus, l'enfance était en crise au Canada et que la situation sanitaire provoque une détérioration de ses droits à l'échelle mondiale. Le bilan dévoilé par le Fonds des Nations unies pour l'enfance qui évalue la situation des enfants et des jeunes âgés de moins de 18 ans dans les pays riches a classé le Canada à la 30e place sur 38 pays.

Latin America - COVID-19 will impact Latin America's educational system for decades

September 18th - But while Latin America's economy will start recovering next year, the damage caused by the COVID-19 pandemic to the region's education systems may last decades. Millions of Latin American children have lost six months of school because of the pandemic, often because they lack laptops or good internet connections to study remotely. In Bolivia, the government canceled classes for the entire 2020 school year. Educators wonder how many children will return to class once schools re-open.

September 24th - UNICEF says corporal and humiliating punishment as a form of violence against children is prevalent in Mexico. Lawmakers have unanimously passed a modification to the General Law on the Rights of Children and Adolescents to prohibit corporal punishment and humiliation of children.

United States of America - California: New Law Protects Children in Police Custody

September 30th - A new California law will protect children in police custody, Human Rights Watch said today. The measure, signed by Governor Gavin Newsom on September 30, 2020, will make sure youth talk with an attorney while deciding whether to waive their rights and submit to police interrogation.

September 28th - Since mid-March, citing public health concerns, the United States has expelled more than 8,700 unaccompanied, vulnerable migrant children who were seeking protection in the U.S. — often sending them back to the violent situations from which they had to flee.
